PROVINCIAL RESOLUTION NO. 904-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – ILOCOS CENTER FOR HEALTH DEVELOPMENT FOR THE IMPLEMENTATION OF THE MEDICAL ASSISTANCE FOR INDIGENT AND FINANCIALLY INCAPACITATED PATIENTS (MAIFIP) PROGRAM IN FOURTEEN (14) GOVERNMENT HOSPITALS OF THE PROVINCE OF PANGASINAN

WHEREAS, the Medical Assistance for Indigent and Financially Incapacitated Patients (MAIFIP) Program is a Department of Health program intended to provide financial support to indigent and poor patients seeking medical examination, consultation, treatment and rehabilitation and those confined in government hospitals;

WHEREAS, the Department of Health – Ilocos Center for Health Development has chosen the Province of Pangasinan to facilitate the implementation of the Medical Assistance for Indigent and Financially Incapacitated Patients (MAIFIP) Program;

WHEREAS, the fourteen provincial government hospitals of the Province of Pangasinan shall implement the MAIFIP with a total budget amounting to P83,801,431.80, as follows:
