#### **RESOLUTION NO. 91-2024**

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2024 OF MABINI, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P192,357,500.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Annual Budget for Calendar Year 2024 involving total appropriations of P192,357,500.00, which was enacted on November 6, 2023 through Appropriation Ordinance No. 2, S-2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the grant of step increment to some municipal officials and employees shall be in accordance with DBM-CSC Joint Circular No. 1, S-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S-2016 dated January 2016;
- 2. That the appropriation for the payment of Terminal Leave Benefits (TLB) shall be subject to the provisions of DBM Budget Circular No.2016-2 dated March 29, 2016 re: Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.1 thereof;

- 3. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No.10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF) and that 30% shall be set aside as Quick Response Fund;
- 4. That the utilization of appropriations from 20% Annual National Tax Allotment for Development Projects (20% Development Fund) shall be in accordance with the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No.1 dated November 4, 2020, Revised Guidelines on the Appropriation and Utilization of Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects;
- 5. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality formulated pursuant and its supplement thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No.1, Series of 2007 dated March 8, 2007;
- 6. That all procurement to be undertaken shall strictly be subject to the pertinent provisions of R.A. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations; and
- 7. That the appropriation for Other Bonuses and Allowances shall only be disbursed in accordance with the guidelines authorizing the same, otherwise, the same may be considered bereft of legal basis.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Annual Budget for Calendar Year 2024 of Mabini, Pangasinan;
