## **RESOLUTION NO. 912-2024**

APPROVING RESOLUTION NO. 2024-375 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2024-03 OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN FOR CALENDAR YEAR 2024, REQUIRING A TOTAL FUNDING OF TWO MILLION SIX HUNDRED SIXTY ONE THOUSAND FOUR HUNDRED SEVENTY NINE PESOS AND FIFTEEN CENTAVOS (P2,661,479.15)"

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2024-375 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Sta. Barbara, Pangasinan prepared the LGU's Supplemental Investment Program (SIP) No. 2024-03, CY 2024. This was endorsed by the Council, through MDC Resolution No. 2024-04, Series of 2024 dated June 28, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- Said Supplemental AIP, which has a total investment requirement of <sup>₽</sup>2,661,479.15, covers fund augmentation for Personal Services (PS) and, Maintenance and Other Operating Expenses (MOOE) of some offices of the LGU; and

> 3. Funding for the full implementation of this Supplemental AIP is embodied in their Supplemental Budget No. 3, FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-042, Series of 2024 dated July 10, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was–
