RESOLUTION NO. 916-2024

DECLARING MUNICIPAL ORDINANCE NO. 2024-07 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “AN ORDINANCE NAMING THE PART OF THE ROUTE LOCATED AT SITIO CAPALDUA IN BARANGAY GUIGUILONEN, MANGALDAN AS THE ABELARDO G. BIALA ROAD” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Municipal Ordinance No. 2024-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 13 of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Gerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2024-07 of the Sangguniang Bayan of Mangaldan, Pangasinan, entitled “An Ordinance naming the part of the route located at Sitio Capaldua in Barangay Guiguilonen, Mangaldan as the Abelardo G. Biala Road” as within the conferred powers of the Sangguniang Bayan to enact;


