### PROVINCIAL RESOLUTION NO. 921-2024

**REQUESTING THE CHIEF OF PHILIPPINE NATIONAL POLICE, MAJOR GENERAL ROMMEL FRANCISCO D. MARBIL THROUGH THE REGIONAL DIRECTOR, BRIGADIER GENERAL LOU F. EVANGELISTA, TO ASSIGN ADDITIONAL POLICE FORCE IN THE PROVINCE OF PANGASINAN TO AUGMENT THE LACKING NUMBER OF POLICE PERSONNEL IN THE DIFFERENT MUNICIPALITIES OF THE PROVINCE**

**WHEREAS**, the Philippine National Police is mandated to enforce the law to prevent and control crimes, maintain peace and order and ensure public safety and security with the active support of the community;

**WHEREAS**, the Province of Pangasinan which is composed of 4 cities and 44 municipalities is one of the most populous provinces in the entire country;

**WHEREAS**, based on the latest census, Pangasinan has a total population of more than 3 million however, the number of policemen assigned in the Province is not ideal to the ratio of the large number of population which the Province has at present;

**WHEREAS**, although the Province of Pangasinan is generally peaceful and orderly, there are instances when lawlessness and other illegal activities are still perpetrated by criminals and so-called wrongdoers;

**WHEREAS**, as a result of the Question Hour undertaken by the Sangguniang Panlalawigan held on October 7, 2024 Regular Session, the Pangasinan Police Provincial Office has informed the Body that one of its enhanced crime prevention strategies is the provision of an effective deployment of personnel through observance and analysis of the crime clock for police visibility to prevent and preempt the occurrence of crimes through foot and mobile patrol;

**NOW THEREFORE**, on motion of SP Member Vici M. Ventanilla, duly seconded, it was -


