RESOLUTION NO. 93-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2023 OF LINGAYEN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P22,078,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2023 involving total appropriations of P22,078,000.00, which was enacted on December 4, 2023 through Appropriation Ordinance No. 04, Series of 2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the subject supplemental budget were determined in accordance with the provisions of Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That the reversion of personal services savings shall be in accordance with the provisions of Section 336 of R. A. No. 7160 (Use of Appropriated Funds & Savings);

- That all programs, projects and activities to be implemented are in accordance with the approved CY 2023 Annual Investment Program of the municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
- 4. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
- 4. That the utilization of appropriations from 20% Development Fund shall be in accordance with the provision of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re: Revised Guidelines on the Appropriation & Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects;
- 5. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRMC –DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 and re Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF);
- That the disbursement of Service Recognition Incentive (SRI) to regular & casual employees for FY 2023 shall be subject to Budget Circular No. 2023-2 dated December 13, 2023; and
- That the grant of Gratuity Pay to Contract of Service and Job Order Workers in Government for FY 2023 of the municipality shall be in accordance with the provisions of Budget Circular No. 2023-3 dated December 14, 2023.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was–

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 3 for Calendar Year 2023 of Lingayen, Pangasinan;
