RESOLUTION NO. 99-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 4 FOR CALENDAR YEAR 2023 OF URBIZTONDO, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P11,493,173.44, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Supplemental Budget No. 4 for CY 2023 involving total appropriations of P11,493,173.44, which was enacted on December 1, 2023 through Appropriation Ordinance No. 5-2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;

- 3. That the grant of Performance Based Bonus for FY 2022 to all qualified officials and employees of the municipality shall be subject to the provisions on Inter-Agency Task Force (IATF) on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems Memorandum Circular No. 2022-1 dated March 24, 2022. Provided further that the LGU can only grant the PBB after receiving the individual Notice of Eligibility and submission of the Form 1 to their respective MLGOO; and
- 4. That the disbursement of Other Personnel Benefits shall be in accordance with the specific guidelines granting the same.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was–

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 4 for Calendar Year 2023 of Urbiztondo, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Urbiztondo, Pangasinan, for its information and guidance.
