PROVINCIAL RESOLUTION NO. 1002-2024

AUTHORIZING THE GOVERNOR, HONORABLE RAMON V. GUICO III, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF PANGASINAN, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TOURISM AND TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY REGARDING THE IMPLEMENTATION OF TOURIST REST AREA PROJECT IN THE CAPITOL AREA, LINGAYEN, PROVINCE OF PANGASINAN

WHEREAS, the Province of Pangasinan in general and the Capitol Area in particular is a major tourist destination in the Ilocos Region which draws considerable volume of tourists per year, thus, the need to implement Tourist Rest Area (TRA) Project to improve the overall tourism experience of visitors;

WHEREAS, the Provincial Capitol Area is known for its historical, cultural, coastal sun and beach tourism products, contributing greatly to the image and branding of Pangasinan, and driver to the provincial economy;

WHEREAS, the Department of Tourism is the primary planning, programming, coordinating, implementing and regulatory government agency in the development and promotion of tourism industry, both domestic and international, in coordination with attached agencies and other government instrumentalities;

WHEREAS, Tourism Infrastructure and Enterprise Zone Authority (TIEZA) is mandated to develop, manage and supervise Tourism Infrastructure Projects in the country that promotes ecologically sustainable and responsible structural project in the community;

WHEREAS, the Tourist Rest Area (TRA) is one of the flagship programs of the Department of Tourism in partnership with TOEZA that aims for local and foreign tourists in need of information on the tourism sites and attractions, activities, accommodations, safety and security and other provisions necessary during their stay;

WHEREFORE, on motion of SP Member Marinor B. de Guzman, duly seconded, it was –


