PROVINCIAL RESOLUTION NO. 1003-2024

A RESOLUTION ACCEPTING THE TOURIST REST AREA (TRA) PROJECT FROM THE TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY ENSURING THE MANAGEMENT, OPERATION AND MAINTENANCE OF THE FACILITY AFTER ITS TURN-OVER TO THE LOCAL GOVERNMENT OF THE PROVINCE OF PANGASINAN

WHEREAS, in order to promote, encourage and develop tourism as a major socio-economic activity and to further improve tourism infrastructure and accessibility and for the enhancement of overall tourist experience, the Department of Tourism (DOT), Tourism Infrastructure and Enterprise Zone Authority (TIEZA), and in coordination with the Local Government Units, espoused to prioritize the Tourist Rest Area (TRA) Project;

WHEREAS, the Tourist Rest Area (TRA) is a venue for local and foreign tourist in need of basic services and amenities, information on the tourism sites and attractions, activities and accommodations, safety and security, and other provisions necessary during their stay;

WHEREAS, as counterpart, the Province of Pangasinan willingly accepts the Tourist Rest Area (TRA) Project from TIEZA ensuring the management, operation and maintenance of the facility after its turn-over to the local government;

WHEREFORE, on motion of SP Member Marinor B. de Guzman, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to accept, as it is hereby accepted, the Tourist Rest Area (TRA) Project from the Tourism Infrastructure and Enterprise Zone Authority ensuring the management, operation and maintenance of the facility after its turn-over to the local government of the Province of Pangasinan;






