### PROVINCIAL RESOLUTION NO. 1004-2024

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE PHYSICIANS FOR PEACE PHILIPPINES, INC. FOR THE CONDUCT OF SKILLS AND TRAINING PROGRAM/WORKSHOP ON PROSTHESIS IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, the Physicians for Peace Philippines, Inc. (PFPPPI) is a registered non-stock, non-profit, non-government humanitarian Philippine Corporation recognized by Department of Health, registered with the Securities and Exchange Commission, and certified by the Philippine Council for NGO Certification throughout the Philippines;

**WHEREAS**, PFPPPI owns and operates the PFPPPI Mobility and Vision Care Programs, recognized by the Department of Health, Department of Education, National Council for Disability Affairs and DOST-PCHRD, with personnel who are skilled in early screening, assessment, provision and aftercare of assistive devices;

**WHEREAS**, the Lingayen District Hospital is one of the fourteen hospitals operated by the Provincial Government of Pangasinan that caters patients coming from the different municipalities of the 2<sup>nd</sup> District of Pangasinan and other nearby localities;

**WHEREAS**, recognizing that there are patients and families of patients at the LDH who require assistive device for mobility and visual impairment, the Province of Pangasinan through the LDH and the PFPPPI had previously entered into and signed a Memorandum of Agreement in 2023, establishing a collaboration in providing appropriate, affordable and accessible assistive devices for mobility and visual impairment to patients and families of patients of the hospital, which includes facilitation of trainings on prostheses;

**WHEREAS**, in its continuing effort to provide effective and quality healthcare service, and also in preparation for the Prosthesis Center to be established in the hospital, the LDH acknowledges the need for essential trainings and workshops to equip and upgrade the personnel's knowledge and skills;

**WHEREAS**, a Memorandum of Agreement shall be entered into between the PFPPI and the LDH for the provision for skills and training program/workshop to be provided by the PFPPI;

**WHEREAS**, the roles and responsibilities of both parties in the conduct of the trainings and workshop are defined in the MOA, wherein the PFPPI shall provide training and/or workshops of the technicians for the prostheses, orthoses and wheelchair rehabilitation, as well as training of the LDH's medical and allied health staff on pre and post prostheses, orthoses and wheelchair rehabilitation, at no cost to the LDH;

**WHEREAS**, Section 465(vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;


**WHEREAS**, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Physicians for Peace Philippines, Inc., represented by Ms. Lyne A. Abanilla, Chief Operating Officer;

**NOW, THEREFORE**, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Physicians for Peace Philippines, Inc. for the conduct of skills and training program/workshop on prosthesis in the Province of Pangasinan.
