RESOLUTION NO. 1013-2024

APPROVING SB RESOLUTION NO. 202-2024 OF THE SANGGUNIANG BAYAN OF MANGATAREM, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 01 FOR FY 2024 OF THE MUNICIPALITY OF MANGATAREM, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its SB Resolution No. 202-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Mangatarem, Pangasinan prepared their Supplemental Investment Program (SIP) No. 01 for CY 2024. This was endorsed by the Council, through MDC ExeCom Resolution No. 02, Series of 2024 dated August 27, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. The Supplemental Investment Program, which has a total investment requirement of ₱73,647,051.00, covers the augmentation of funds for Personal Services (Implementation of the First Tranche of the Modified Salary Schedule to all municipal officials and employees, and other personnel benefits), Maintenance and Other Operating Expenses of some municipal offices and implementation of LDRRM program, development projects and other priority projects of the Municipal Government;

3. The projects proposed for funding from the 20% Development Fund are based on the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the IRA for Development Projects).

Also, the projects proposed to be funded from the 5% LDRRM Fund are based on the Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund); and

4. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 01, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01, Series of 2024 dated August 29, 2024 and approved by the Municipal Mayor on August 30, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangatarem, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


