DECLARING SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2024 OF MANGATAREM, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P73,647,051.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its Supplemental Budget No. 1 for CY 2024 involving total appropriations of P73,647,051.00, which was enacted on August 29, 2024 through Appropriation Ordinance No. 01, Series of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the implementation of the First Tranche salary adjustment to all municipal officials and employees shall be in accordance with the Local Budget Circular No. 160 dated August 12, 2024 specifically item 5.0 thereof;
- 2. That the disbursement of additional One Thousand Pesos (P1,000.00) in Uniform Clothing Allowance shall be in accordance with the Budget Circular No. 2024-1 dated April 4, 2024;

- 3. That the grant for Performance Based Bonus (PBB) for FY 2023 shall only be disbursed upon the issuance of guidelines from proper authority authorizing the same;
- 4. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, series of 2007 dated 08 March 2007;
- 5. That the grant of increase in Representation and Transportation Allowance (RATA) shall be in accordance to the provisions of Local Budget Circular No. 157 dated May 3, 2024 of the Department of Budget and Management;
- 6. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 414 (a) of its IRR as amended by Administrative Order No. 47, dated April 12, 1993;
- 7. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its implementing Rules and Regulations, and
- 8. That the reversion of savings shall be in accordance with the provisions of Section 336 of R.A. No. 7160 (Use of Appropriated Funds and Savings).

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 1 for Calendar Year 2024 of Mangatarem, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Mangatarem, Pangasinan, for its information and guidance.
