#### APPROVING RESOLUTION NO. 115-2024 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 CY 2024 OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its SB Resolution No. 115-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of San Jacinto, Pangasinan prepared the municipality's Supplemental Investment Program No. 2 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 2024-02 dated August 20, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- The Supplemental AIP, which has a total investment requirement of ₱10,485,419.50, covers the augmentation of funds for Personal Services (to include the implementation of the First Tranche of the Modified Salary Schedule for LGU Personnel) Fund augmentation for the Maintenance and Other Operating Expenses (MOOE) of some municipal offices and implementation of development projects of the Municipal Government;

- The projects proposed to be funded from the 20% Development Fund, are based on the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects); and
- 4. Funding support for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 2, CY 2024, which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2024-02, Series of 2024, dated August 30, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Jacinto, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. de Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was–

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 115-2024 of the Sangguniang Bayan of San Jacinto, Pangasinan, entitled "Approving the Supplemental Investment Program No. 2 CY 2024 of the Municipality of San Jacinto, Pangasinan";
