#### **RESOLUTION NO. 1017-2024**

DECLARING SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2024 OF SAN JACINTO, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P10,485,419.50, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Supplemental Budget No. 2 for CY 2024 involving total appropriations of P10,485,419.50, which was enacted on August 30, 2024 through Appropriation Ordinance No. 2024-02;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That all programs, projects and activities to be implemented are in accordance with the approved CY 2024 Annual Investment Program of the Municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF JMC No. 1, Series of 2007 dated March 8, 2007;

- 3. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
- 4. That the grant of the First Tranche salary adjustment to all municipal officials and employees shall be implemented in accordance to the issued Local Budget Circular Number 160 by the Department of Budget and Management dated August 12, 2024, specifically item 5.0 thereof;
- 5. That the appropriation for the additional employer (government) share in the premium contributions to the Home Development Mutual Fund (PAG-IBIG FUND) shall be in accordance to DBM Circular Letter No. 2024-2 dated February 1, 2024;
- 6. That the appropriation for the employer (government) share in the premium contributions to the Philippine Health Insurance Corporation (PhilHealth) shall be in accordance to PhilHealth Circular Letter No. 2019-0009 dated October 25, 2019;
- 7. That the projects funded under the 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re: "Revised Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects."; and
- 8. That the appropriation of Bids and Awards Committee Honoraria must be in accordance to Budget Circular No. 2004-5A dated October 7, 2005 re: "Guidelines on the Grant of Honoraria to Government Personnel Involved in Government Procurement".

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. de Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
