**PROVINCIAL RESOLUTION NO. 320-2024**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH CENTER FOR HEALTH DEVELOPMENT-I (DOH CHD I) FOR THE IMPLEMENTATION OF THE MEDICAL ASSISTANCE FOR INDIGENT AND FINANCIALLY INCAPACITATED PATIENTS (MAIFIP) PROGRAM IN FOURTEEN (14) GOVERNMENT HOSPITALS OF THE PROVINCE OF PANGASINAN**

**WHEREAS**, the Medical Assistance for Indigent and Financially Incapacitated Patients (MAIFIP) Program is a Department of Health program intended to provide financial support to indigent and poor patients seeking medical examination, consultation, treatment and rehabilitation and those confined in government hospitals;

**WHEREAS**, the Department of Health Center for Health Development-I (DOH CHD I) has chosen the Province of Pangasinan to facilitate the implementation of the Medical Assistance for Indigent and Financially Incapacitated Patients (MAIFIP) Program;

**WHEREAS**, the fourteen provincial government hospitals of the Province of Pangasinan shall implement the MAIFIP with a total budget amounting to P55,440,000.00, as follows:

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Department of Health Center for Health Development-I (DOH CHD I) for the implementation of the Medical Assistance for Indigent and Financially Incapacitated Patients (MAIFIP) Program in fourteen (14) government hospitals of the Province of Pangasinan;
