AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO EXECUTE A DEED OF DONATION IN FAVOR OF THE TUGUI GRANDE FRESH PRODUCE FARMERS ASSOCIATION INC.; INTEGRATED SMALL FISHPOND OWNERS AND LESSEES MULTI-PURPOSE COOPERATIVE (ISFOL-MPC); URDANETA CITY ORGANIC FARMING RICE CORN VEGETABLES GROWERS ASSOCIATION; ALCALA ONION GROWERS MULTI-PURPOSE COOPERATIVES; AND BOLO BONGALON MAGSAYSAY DULIG SAN GONZALO AGRARIAN REFORM COMMUNITY MULTI-PURPOSE COOPERATIVE (BOMADUC ARC-MPC) AS BENEFICIARIES OF THE IDENTIFIED PROJECTS FUNDED UNDER THE PHILIPPINE RURAL DEVELOPMENT PROGRAM (PRDP)

WHEREAS, the Philippine Rural Development Program (PRDP) is a poverty-reduction and agriculture and fisheries development program of the Department of Agriculture in partnership with local government units which intends to strengthen the agricultural sector through the establishment of needed rural infrastructure and other livelihood community projects;

WHEREAS, Philippine Rural Development Program is designed as an Adaptable Loan Program (ALP) jointly funded by the International Bank for Reconstruction and Development – World Bank, the national government and the LGU – beneficiaries;

WHEREAS, the Provincial Government of Pangasinan has been constantly championing the farmers and fisherfolks' associations of the Province through its participation in the implementation of the projects funded under the Philippine Rural Development Program of the Department of Agriculture;

WHEREAS, in its support to the implementation of the identified PRDP projects, the Provincial Government of Pangasinan intends to donate/provide building structure, agricultural vehicle and equipment and other necessary facilities that will help improve their production and raise incomes;

WHEREAS, the following farmers and fisherfolks' associations of the Province are identified as PRDP beneficiaries of projects, by way of a donation, from the Provincial Government of Pangasinan:

- 1) Tugui Grande Fresh Produce Farmers Association Inc., Bani, Pangasinan
 - a. Building structure for the Project entitled: "Salad Tomato Contract Farming and Support Service Facility Enterprise" covering an area of 150 sq. m. owned by the Tugui Grande Farmers' Association
 - b. 1 unit of farm tractor with complete accessories
 - c. 5 units of grass cutter (4 stroke)
 - d. 2 units of multi-cultivator (Diesel tiller machine)
 - e. 5 units of pump engine (5HP Engine (Gasoline) 5.5, 3"0 Pump)
- 2) Integrated Small Fishpond Owners and Lessees Multi-Purpose Cooperative (ISFOL-MPC), Binmaley, Pangasinan
 - a. Building structure for the subproject entitled: "Production and Marketing of Processed Bangus Enterprise covering an area of 110 square meters owned by the ISFOL-MPC;
 - b. 1 unit of fabricated sidecar (*garung*)
 - c. 1 unit of motorcycle
 - d. 1 unit of multi-purpose vehicle
 - e. 1 unit of generator
 - f. 1 unit of blast freezer
 - g. 2 units of chest freezer
 - h. 2 units of chiller/freezer
 - i. 2 units of air-conditioning units; and
 - j. 2 units of vacuum sealer
- 3) Urdaneta City Organic Farming Rice Corn Vegetables Growers Association, Urdaneta City, Pangasinan
 - a. 1 unit of Hauling/Delivery Truck for the project entitled: "Fresh Tomato Consolidation and Trading Enterprise"
- 4) Alcala Onion Growers Multi-Purpose Cooperatives, Alcala, Pangasinan
 - a. 1 unit of Hauling/Delivery Truck for the project entitled: "Yellow Granex Production Consolidation and Trading Enterprise"
 - b. 1 unit of weighing scale (1,000 kgs capacity)

- 5) Bolo Bongalon Magsaysay Dulig San Gonzalo Agrarian Reform Community Multi-Purpose Cooperative (BOMADUC ARC-MPC), Labrador, Pangasinan
 - a. 1 unit of delivery truck
 - b. 2 units of engine pump
 - c. 1 unit of axial flow pipe

WHEREAS, the abovementioned donations by the Provincial Government of Pangasinan could directly benefit the identified PRDP beneficiaries by way of increasing their rural incomes and enhancing farm and fishery productivity;

WHEREAS, the Sangguniang Panlalawigan manifested its willingness to support the donation in the spirit of cooperation and mutual assistance to bring further improvement on the productivity of small farmers and fisherfolk as well as their access to markets;

WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance;

NOW, THEREFORE, in view of the foregoing, on motion of SP Member Nicholi Jan Louie Q. Sison and co-authored by SP Members Napoleon C. Fontelera, Jr. Apolonia DG. Bacay, Philip Theodore E. Cruz, Haidee S. Pacheco and Rosary Gracia P. Perez-Tababa, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. 
