**PROVINCIAL RESOLUTION NO. 323-2024**

**RATIFYING THE MEMORANDUM OF UNDERSTANDING (MOU) ENTERED INTO AND SIGNED BY THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, WITH THE PHILIPPINE DRUG ENFORCEMENT AGENCY-REGION I, PNP-PANGASINAN POLICE PROVINCIAL OFFICE, BUREAU OF FIRE PROTECTION-PANGASINAN, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT-REGION I, DEPARTMENT OF EDUCATION, TECHNICAL EDUCATION SKILLS DEVELOPMENT AUTHORITY-PROVINCIAL TRAINING CENTER, RELIGIOUS SECTOR-PANGASINAN ALLIANCE OF MINISTERIAL ASSOCIATION NOW IN ACTION (PAMANA), AND THE PROVINCIAL HEALTH OFFICE FOR THE IMPLEMENTATION OF THE BALAY SILANGAN DRUG REFORMATION PROGRAM IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, received by the Sangguniang Panlalawigan for appropriate action is a letter of Mr. Norman V. Ramos, Pangasinan Anti-Drug Abuse Council (PADAC) Secretariat Chairman, dated February 28, 2024, requesting to allow the expansion and provincial rationalization of the Balay Silangan Drug Reformation Program, which has been the subject of a previous authority granted to the Provincial Governor, Ramon V. Guico III, through Provincial Resolution No. 75-2023 approved on February 6, 2023;

**WHEREAS**, the Memorandum of Understanding (MOU) was executed between the Province of Pangasinan and the concerned parties and was notarized on December 7, 2023;

**WHEREAS**, however, changes have been necessary in the MOU to rationalize the actual agency parties, their responsibilities, and area of operation of the Provincial Balay Silangan Drug Reformation Center which was reviewed by the Philippine Drug Enforcement Agency (PDEA);

**WHEREAS**, the amendment in the MOU is in order to expand the facility-centered operation of the Provincial Balay Silangan Drug Reformation Center into province-wide operation;

**WHEREAS**, for the above purpose, ratification of the Memorandum of Understanding is needed to outline the undertakings of the Province of Pangasinan and the aforementioned parties in the successful implementation of the Balay Silangan Drug Reformation Program;
