RESOLUTION NO. 328-2024

DECLARING MUNICIPAL ORDINANCE NO. 004-2023 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE NEW PERMANENT POSITIONS IN THE MUNICIPAL GOVERNMENT OF MALASIQUI, AS FOLLOWS: 1) 2 MEDICAL SPECIALIST I, SG-22; 2) 2 MEDICAL OFFICER III, SG-21; 3) 1 NURSE II, SG 17; 4). 3 NURSE I, SG-15; 5) 4 MIDWIFE II, SG-11; 6) 1 MEDICAL TECHNOLOGIST I, SG-11; 7) 1 RADIOLOGIC TECHNOLOGIST I, SG-11, ALL OF THE OFFICE OF THE HEALTH SERVICES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its Municipal Ordinance No. 004-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 & 447 (a) (1) (viii) of R. A. No. 7160;

WHEREAS, out of the 14 proposed positions being created, only the positions of Medical Specialist (SG 22) and Medical Officer III (SG 21) were included in the plantilla of personnel and provided with Personal Services appropriation in the Annual Budget for CY 2024, therefore the other positions being created should be adequately provided with funding requirements for basic salary and other associated compensation to be considered properly created positions;


