#### **RESOLUTION NO. 331-2024**

DECLARING MUNICIPAL ORDINANCE NO. 2023-05 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "AN **CREATING ORDINANCE** DIFFERENT PLANTILLA POSITIONS UNDER DIFFERENT OFFICES IN THE MUNICIPALITY OF MANGALDAN, **PANGASINAN FUNDS THEREOF"** APPROPRIATING AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2023-05 of the Sangguniang Bayan of Mangaldan, Pangasinan, entitled "An Ordinance creating different plantilla positions under different offices in the Municipality of Mangaldan, Pangasinan and appropriating funds thereof" as within the conferred powers of the Sangguniang Bayan to enact;
