DECLARING MUNICIPAL ORDINANCE NO. 2023-07 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING A DRUG – FREE WORKPLACE IN THE LOCAL GOVERNMENT OF BINALONAN AND APPROPRIATING FUNDS FOR THE IMPLEMENTATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2023-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 447 (a) (1) (v) of R.A. 7160; Sec. 2 of R.A. No. 9165 also known as the Comprehensive Dangerous Drugs Act of 2002; and Resolution No. 1700653 promulgated on 15 March 2017 of the Civil Service Commission;

WHEREAS, subject ordinance shall take effect after compliance with the publication requirement pursuant to Section 511 (a) of R.A. No. 7160;
