DECLARING MUNICIPAL ORDINANCE NO. 2023-09 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FOR THE NEW TRICYCLE FARE-RATES IN THE MUNICIPALITY OF BINALONAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2023-09 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129, 132, 447 (a) (3) (i) (vi) of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after compliance with the publication requirement pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2023-09 of the Sangguniang Bayan of Binalonan, Pangasinan, entitled "An Ordinance providing for the new tricycle fare-rates in the Municipality of Binalonan, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
