RESOLUTION NO. 341-2024

DECLARING MUNICIPAL ORDINANCE NO. 160, S-2023 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “AN ORDINANCE RENAMING “FORESTER JOSE “PEPE” A. CABANAYAN, SR. FOREST NURSERY AND NATURE PARK” TO ÁGPAY ECO-TOURISM PARK” LOCATED IN BARANGAY SAN FELIPE EAST, THIS MUNICIPALITY” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 160, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 13 (c) (1) (2) (3) (4) (5) (d) (h) of R. A. No. 7160;

WHEREAS, the Sangguniang Bayan shall submit proof that a prior consultation with the National Historical Institute has been made and shall cause the posting of the subject ordinance pursuant to Section 59 of R.A. No. 7160;


