AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A CONTRACT AGREEMENT WITH MR. NARCISO N. SANTOS, JR. FOR THE CONDUCT OF PangaSINE FILM FESTIVAL 2024 IN THE CELEBRATION OF THE PISTA'Y DAYAT 2024

WHEREAS, Pista'y Dayat is a sea festival celebrated annually by the Province of Pangasinan in thanksgiving for the bountiful harvest and abundant fishing including the pleasures being enjoyed by the people from Pangasinan waters;

WHEREAS, for this year's celebration of the Pista'y Dayat, Mr. Narciso N. Santos, Jr. shall be the strategic partner of the Provincial Government of Pangasinan in the presentation of PangaSINE 2024: The Official Film Festival of the Province of Pangasinan, with its Festival Theme: "Pangasinan Through the Lens of the Pangasinense", as well as the conduct of film-making workshops;
