APPROVING RESOLUTION NO. 381-12272023 THE OF SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, **ENTITLED** "APPROVING THE **ANNUAL INVESTMENT** PROGRAM OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN FOR CY 2024 FUNDED BY THE GENERAL FUND, 20% DEVELOPMENT FUND, 5% LDRRM FUND AND NATIONAL TAX ALLOTMENT OF THE LGU FOR 2024"

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its SB Resolution No. 381-12272023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- 1. In pursuance to Sections 106, 109, and 114 of the Local Government Code of 1991, the Local Development Council of Pozorrubio, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2024, which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 3, Series of 2023 dated September 28, 2023;
- 2. The AIP of the municipality is in accordance with the Budget Operations Manual (BOM) for LGUs, 2023 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 series of 2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No.2015-01 dated July 23, 2015 as to format and content. The AIP of Pozorrubio, Pangasinan was

formulated following the prescribed AIP Summary Form categorized into general public, social, economic, and other services. It likewise covers: (a) all the regular budgetary items for the operations of the different municipal offices broken down into PS, MOOE, Financial Expenses and Capital Outlay; (b) the priority development programs/projects and those to be funded by the 20% development fund, and; (c) disaster risk reduction management programs/projects/activities of the municipality. It further includes the following: 1) Gender and Development Plan, Peace and Order Plan and Anti-Drug Abuse Council Action Plan, Local Nutrition Action Plan, and Tourism/Cultural Development Plan, Climate Change Action Plan, Local Youth Development Plan, Annual Procurement Plan, and; 2) list of programs/projects/activities for the Local Council for Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome;

- 3. The proposed AIP has a total investment requirement of Php 301,562,870.20 which will be funded from the municipality's proposed 2024 Annual Budget, enacted on December 27, 2023 through Appropriation Ordinance No. 04-12272023 and approved by the Municipal Mayor on December 28, 2023;
- 4. The development fund amounting to 60,000,000.00 which is allocated for development projects is more than twenty percent (23.53%) of the municipality's NTA amounting to Php 255,015,582.00 for CY 2024. This is in accordance with Section 287 of RA 7160. The identified development programs/projects to be funded by the 20% of NTA are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);
- 5. The attached Disaster Risk Reduction and Management Programs/Projects/Activities in preparation for and to mitigate the impact of disasters to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to Php 15,000,000.00 conforms with Section 21 of RA 10121. The programs/projects to be funded from the 70% of the LDRRMF Php 10,500,000.00 are based on the NDRRMC-DBM and DILG Joint Memo Circular No.2013-1dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund) and the 30% amounting to Php 4,500,000.00 is allocated for Quick Response Fund (QRF). Further, the LDRRMF Plan 2024 of the municipality has been reviewed by the Office of Civil Defense (OCD) as per attached OCD Certification dated December 15, 2023;

- 6. The LGU has also identified programs/projects/activities responsive to climate change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015; and
- 7. The Gender and Development Plan of the municipality has been reviewed by the Department of the Interior and Local Government (DILG) and was found to be fully compliant in form and contents with the provisions of the PCW-DILG-DBM-NEDA Joint Memo Circular of 2016-01: Amendments to JMC 2013-01 re: Guidelines on Localization of the Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated February 21, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Pozorrubio, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 381-12272023 of the Sangguniang Bayan of Pozorrubio, Pangasinan, entitled "Approving the Annual Investment Program of the Municipality of Pozorrubio, Pangasinan for CY 2024 funded by the General Fund, 20% Development Fund, 5% LDRRM fund and National Tax Allotment of the LGU for 2024";
