**PROVINCIAL RESOLUTION NO. 369-2024**

**ENJOINING ALL BARANGAYS IN THE MUNICIPALITIES AND  
COMPONENT CITIES OF THE PROVINCE OF PANGASINAN TO  
ENACT AN ORDINANCE CREATING BARANGAY EMPLOYMENT  
SERVICE OFFICES (BESOs)**

**WHEREAS**, Section 9, Article 2 of the 1987 Philippine Constitution states that the State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all;

**WHEREAS**, Section 5 (e) and (f) of Republic Act No. 8759, also known as the “Public Employment Service Office (PESO) Act of 1999”, institutionalized the establishment of the Public Employment Service Office which functions to “provide employment and occupational counseling, career guidance, mass motivation and values development activities” and to “conduct pre-employment counseling and orientation in prospective local and overseas workers”;

**WHEREAS**, Section 6 of Republic Act 10691 states that every PESO shall undertake holistic strategies, programs and activities to transform the PESO into a modern employment service intermediary that provides multi-dimensional employment facilitation services;

**WHEREAS**, Chapter 2, Section 16 of Republic Act 7160, also known as the Local Government Code of 1991, mandates the Local Government Unit to ensure and support the promotion of full employment among their residents;

**WHEREAS**, the purpose of establishing Barangay Employment Service Offices (BESOs) is to ensure the prompt delivery of information and provide employment services by identifying job opportunities in each and every barangay in Pangasinan;


