**PROVINCIAL RESOLUTION NO. 371-2024**

**AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH VISITING CONSULTANTS (CARDIOLOGISTS AND 2D ECHO READER) RELATIVE TO THEIR SERVICES AT THE PANGASINAN PROVINCIAL HOSPITAL**

**WHEREAS**, the Pangasinan Provincial Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, is in need of the services of Cardiologists and 2D Echo Reader;

**WHEREAS**, the Cardiologists and 2D Echo Reader, who have signified their intention to provide the services needed by the Pangasinan Provincial Hospital, possess the education, experience and skills or specialization required to perform the services of Cardiologists and 2D Echo Reader;

**WHEREAS**, Department of Health Administrative Order No. 172, S-2021, entitled "Policies and Guidelines on the Private Practice of Medical and Paramedical Professionals in Government Health Facilities" encourages the employment of physicians and paramedical personnel who are experts in their field of practice in various government hospitals and other government health facilities;

**WHEREAS**, it is essential for the Province to engage the services of the visiting Cardiologists and 2D Echo Reader to further enhance the quality of health services of the Pangasinan Provincial Hospital;

**WHEREAS**, the duties and responsibilities of the parties for the said undertaking are already defined in the Memorandum of Agreement (MOA);

**NOW, THEREFORE**, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


