RESOLUTION NO. 376-2024

DECLARING ORDINANCE NO. 24-02 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “AN ORDINANCE APPROVING AND ADOPTING THE PROPOSED TRANSFER OF THE POSITION OF ENVIRONMENTAL MANAGEMENT SPECIALIST II, SALARY GRADE 15, ITEM NO. 5 FROM THE GENERAL SERVICES OFFICE TO CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE IN THE CITY GOVERNMENT OF SAN CARLOS, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT




