**DECLARING ORDINANCE NO. 24-02 OF THE SANGGUNIANG** PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING AND ADOPTING THE PROPOSED TRANSFER OF THE POSITION OF **ENVIRONMENTAL MANAGEMENT SPECIALIST II, SALARY GRADE 15, ITEM NO. 5** FROM THE GENERAL SERVICES **OFFICE** TO CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE IN THE CITY GOVERNMENT OF SAN CARLOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
