RESOLUTION NO. 377-2024

APPROVING MUNICIPAL RESOLUTION NO. 2023-232 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 03 FOR CALENDAR YEAR 2023 OF THE MUNICIPALITY OF ALCALA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Resolution No. 2023-232 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Alcala, Pangasinan has identified items in their Supplemental Annual Investment Program No. 03. This was endorsed to the Sangguniang Bayan for approval on December 18, 2023 by the Municipal Development Council Executive Committee thru Resolution No. 2023-02;
2. The Said SAIP covers fund augmentation for Personal Services (payment of Service Recognition Incentives for qualified LGU Personnel), Maintenance and Other Operating Expenses of some municipal offices and implementation of disaster risk reduction program of the LGU with a total investment requirement of Php5,110,336.57; and

3. Funding support for the full implementation of the same in the amount of Php5,110,336.57 is embodied in their proposed Supplemental Budget No. 3 for Calendar Year 2023 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 2023-04 on December 18, 2023.




