## **PROPOSED RESOLUTION NO. 382-2024**

## DECLARING MUNICIPAL ORDINANCE NO. 2023-007 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "AN ORDINANCE TO PREPARE FOR AND RESPOND TO THE IMPACTS OF EL NIÑO IN THE MUNICIPALITY OF LAOAC, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Municipal Ordinance No. 2023-007 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 and 447 (a) (1) (iv) of R. A. No. 7160; and DILG Memorandum Circular No. 2023-065, entitled: "Mitigation and Preparedness Measures for the El Niño Phenomenon 2023";

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-
