RESOLUTION NO. 383-2024

DECLARING MUNICIPAL ORDINANCE NO. 2023-011 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING LOCAL JUVENILE INTERVENTION AND DIVERSION PROGRAMS, PURSUANT TO THE PROVISIONS OF JUVENILE JUSTICE WELFARE ACT OF 2006 (RA 9344), PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Municipal Ordinance No. 2023-011 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with The United Nations Convention on the Rights of the Child (CRC); Presidential Decree No. 603 or “The Child and Youth Welfare Code; R.A. No. 9344 also known as, “Juvenile Justice and Welfare Act of 2006; and Sections 17 (b) (2) (iii) (iv) (5) (xiv) and 447 (a) (5) (xiv) of R. A. No. 7160;


