DECLARING MUNICIPAL ORDINANCE NO. 2023-012 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE PROGRAMS, SERVICES, PRIVILEGES AND BENEFITS FOR SOLO PARENTS AND THEIR CHILDREN AND APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES PURSUANT TO REPUBLIC ACT 8972 (RA 8972) OR THE "SOLO PARENTS WELFARE ACT OF 2000" AS AMENDED BY REPUBLIC ACT 118611 (RA 118611) OR THE "EXPANDED SOLO PARENTS WELFARE ACT" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Municipal Ordinance No. 2023-012 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2), & 447 (a) (5) (xiv) of R. A. No. 7160; Republic Act No. 8972, otherwise known as the "Solo Parents Welfare Act of 2000; and Republic Act No. 11861, or the "Expanded Solo Parents Welfare Act";
