### PROVINCIAL RESOLUTION NO. 391-2024

#### **APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2024**

**WHEREAS**, presented for consideration is the Supplemental Investment Program No. 2 of the Province of Pangasinan for Calendar Year 2024 as endorsed by the Provincial Development Council through PDC Resolution No. 01, S-2024;

**WHEREAS**, Supplemental Investment Program No. 2 contains other priority programs, projects and activities that are not included in the approved 2024 Annual/Supplemental Investment Program of the Province of Pangasinan;

**WHEREAS**, programs and projects included in the Supplemental Investment Program covers fund augmentation for Office Supplies Expenses, Personal Services, Other Maintenance and Operating Expenses and Capital Outlay of provincial offices as well as implementation of other priority programs and projects of the province;

**WHEREAS**, the Supplemental Investment Program covers landbanking and right of way acquisition, purchase of vehicles for the smooth implementation of various programs and projects of the province, Operation of Pangasinan Salt Center, counterpart for Philippine Rural Development Project (PRDP) and various infrastructure support projects;

**WHEREAS**, also included in the Supplemental Investment Program is the procurement of assorted vegetable seeds, feeds, supplements, drugs and biologics and the re-stocking of large and small ruminants/livestock to be funded from the Quick Response Fund of the Department of Agriculture;

**WHEREAS**, the Supplemental Investment Program likewise includes the revised/refined programs, projects and activities of the Provincial Health Office as embodied in the Annual Investment Program (AIP) for CY 2024 to accommodate changes in the expected output but with no changes in the total financial requirement;
