PROVINCIAL RESOLUTION NO. 395-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH ALV PAGEANT CIRCLE MANAGEMENT, INC. FOR ITS PARTICIPATION IN THE CONDUCT OF THE MISS WORLD PHILIPPINES AND MISS GRAND PHILIPPINES IN THE PROVINCE OF PANGASINAN

WHEREAS, one of the visions of the present administration is to make Pangasinan a premier province and its people worthy of international recognitions;

WHEREAS, it is the aim of the Provincial Government of Pangasinan to fulfill such vision by way of supporting and promoting tourism development programs and projects;

WHEREAS, relative thereto, the Provincial Government of Pangasinan intends to accept the proposal to operate and own a franchise in the conduct of a beauty pageant competition offered by ALV Pageant Circle Management, Inc., the holder of Exclusive License from Miss World Limited and Miss Grand International Company Limited;

WHEREAS, the Provincial Government of Pangasinan shall organize its own beauty contest wherein the winners of said event will represent the Province as candidates for the Miss World Philippines and Miss Grand Philippines;

WHEREAS, honoring the said Agreement, the ALV Pageant Circle Management, Inc. shall recognize and accept the winners of the beauty pageant conducted by the Province as automatic candidates of the Miss World Philippines and Miss Grand Philippines;

WHEREAS, the Sangguniang Panlalawigan expresses its support to this Program in order to provide the winners the opportunity to represent the Province in various national and international beauty pageants;

WHEREAS, the stipulations, covenants, terms and conditions of the ALV Pageant Circle Management, Inc. and the Province of Pangasinan in the conduct of the beauty pageant are stipulated in a Memorandum of Agreement (MOA);

WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;


WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed by and between the Province of Pangasinan, represented by Honorable Governor Ramon V. Guico III, and ALV Pageant Circle Management, Inc., represented by its Chairman and Chief Executive Officer, Mr. Arnold L. Vegafria;

NOW, THEREFORE, on motion of SP Member Marinor B. de Guzman, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan of Pangasinan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into a Memorandum of Agreement (MOA) with ALV Pageant Circle Management, Inc. for its participation in the conduct of the Miss World Philippines and Miss Grand Philippines in the Province of Pangasinan;
