RESOLUTION NO. 407-2024

DECLARING MUNICIPAL ORDINANCE NO. 2023-12 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE CREATING VARIOUS POSITIONS OF THE MUNICIPAL GOVERNMENT OF ALCALA, PANGASINAN, DETERMINING ITS DUTIES AND RESPONSIBILITIES AND PROVIDING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Ordinance No. 2023-12 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 76, and 447 (a) (1) (viii) of R. A. No. 7160;

WHEREAS, under Section 1 of the subject ordinance enumerates the creation of position. The position of Person with Disability Affairs Officer I (SG-11) should be changed to Disability Affairs Officer I (SG-11) to conform with the provision of Local Budget Circular No. 137 dated July 13, 2021;




