RESOLUTION NO. 410-2024

DECLARING MUNICIPAL ORDINANCE NO. 2024-01 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING A ONE MILLION THIRTY SEVEN THOUSAND TWO HUNDRED FIFTY FOUR (1,037,254) SQUARE METERS, MORE OR LESS, PARCELS OF LAND LOCATED AT BARANGAYS MORENO AND STA. CATALINA, BINALONAN, PANGASINAN APPLIED FOR BY THE CITICORE SOLAR PANGASINAN 2, INC. FROM AGRICULTURAL LANDS TO COMMERCIAL/INDUSTRIAL LANDS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2024-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Provincial Planning and Development Coordinator have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 20 (a) (2) (3) (c) (d) (e), and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the Municipality of Binalonan has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan 2012-2021, however it needs to be updated. A public hearing was conducted for the reclassification of said parcel of land wherein the barangay officials and residents posed no objection on the proposed solar power project subject for land reclassification;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2024-01 of the Sangguniang Bayan of Binalonan, Pangasinan, entitled "An Ordinance reclassifying a one million thirty seven thousand two hundred fifty four (1,037,254) square meters, more or less, parcels of land located at Barangays Moreno and Sta. Catalina, Binalonan, Pangasinan applied for by the Citicore Solar Pangasinan 2, Inc. from agricultural lands to commercial/industrial land" as within the conferred powers of the Sangguniang Bayan to enact;
