DECLARING MUNICIPAL ORDINANCE NO. 161, S-2023 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING CERTAIN PROVISIONS SPECIFICALLY SECTION 3 ON FEES AND SECTION 6 ON PROHIBITED ACTS OF MUNICIPAL ORDINANCE NO. 136 S. 2022 ENTITLED: CHARGING FEES TO ALL LOCAL AND FOREIGN GUESTS/TOURISTS ENTERING THE AGPAY ECOTOURISM PARK AND PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 161, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129, 132, 447 (a) (3) (i) of R. A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R. A. No. 7160;
