PROVINCIAL RESOLUTION NO. 414-2024

FAVORABLY ENDORSING VARIOUS DREDGING PROJECTS IN THE PROVINCE OF PANGASINAN, NAMELY: DESILTING OF APLAYA CREEK IN BARANGAY PANGAPISAN NORTH, LINGAYEN; DREDGING OF AGNO RIVER AND OTHER TRIBUTARIES IN ROSALES; AND THE PANTAL RIVER DREDGING PROJECT IN DAGUPAN CITY, ALL OF PANGASINAN, UNDER THE DPWH REGIONAL INFRASTRUCTURE PROJECT FUNDED UNDER THE FY 2024 GENERAL APPROPRIATIONS ACT

WHEREAS, the Department of Public Works and Highways – Regional Office I, through Regional Director Ronnel M. Tan, requested the Sangguniang Panlalawigan and the Province of Pangasinan for a favorable endorsement for various dredging projects in the Province, as a requirement to the DPWH-R1's application for a Certificate of Non-Coverage (CNC)/Environmental Compliance Certificate (ECC);

WHEREAS, the following dredging projects shall be under the DPWH Regional Infrastructure Project funded under the FY 2024 General Appropriations Act:

- a. Desilting of Aplaya Creek in Barangay Pangapisan North, Lingayen, Pangasinan;
- b. Dredging of Agno River and other tributaries at Rosales, Pangasinan; and
- c. Pantal River Dredging Project in Dagupan City, Pangasinan

WHEREAS, the said project aims to remove sediments and other silt materials from the waterway to deepen its stream and to ensure the unrestricted waterflow in the rivers and creeks within the territorial waters of Pangasinan;

WHEREAS, there is a need for the Sangguniang Panlalawigan of Pangasinan to pass a resolution favorably endorsing the abovementioned projects in the Province through the DPWH-Regional Office I;

WHEREAS, acknowledging the importance of the aforesaid projects to protect the territorial waters of the Province, the Sangguniang Panlalawigan shall favorably endorse the projects: *Provided*, that before the start of every dredging activity, the project proponent shall pre-identify a stockyard where the minerals to be extracted shall be deposited, and provided further, that the minerals/deposits collected shall be under the jurisdiction and disposition of the Provincial Government;

NOW, THEREFORE, on motion of SP Members Salvador S. Perez, Jr. and Vici M. Ventanilla, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to favorably endorse, as it is hereby favorably endorsed, various dredging projects in the Province of Pangasinan, namely: Desilting of Aplaya Creek in Barangay Pangapisan North, Lingayen; Dredging of Agno River and Other Tributaries in Rosales; and the Pantal River Dredging Project in Dagupan City, all of Pangasinan, under the DPWH Regional Infrastructure Project funded under the FY 2024 General Appropriations Act;
