PROVINCIAL RESOLUTION NO. 415-2024

FAVORABLY ENDORSING THE CONSTRUCTION /MAINTENANCE OF FLOOD MITIGATION STRUCTURES AND DRAINAGE SYSTEMS, REHABILITATION OF FLOOD MITIGATION STRUCTURE, LIMAHONG RIVER CHANNEL, PHASE I-III, LOCATED AT BARANGAY PANGAPISAN NORTH, LINGAYEN, PANGASINAN, UNDER THE DPWH REGIONAL INFRASTRUCTURE PROJECT FUNDED UNDER THE FY 2024 GENERAL APPROPRIATIONS ACT

WHEREAS, the Department of Public Works and Highways – Regional Office I, through Regional Director Ronnel M. Tan, requested the Sangguniang Panlalawigan and the Province of Pangasinan for a favorable endorsement for various projects in the Province, as a requirement to the DPWH-R1's application for a Certificate of Non-Coverage (CNC)/Environmental Compliance Certificate (ECC);

WHEREAS, the said projects shall be under the DPWH Regional Infrastructure Project funded under the FY 2024 General Appropriations Act, namely: Construction/Maintenance of Flood Mitigation Structures and Drainage Systems, Rehabilitation of Flood Mitigation Structure, Limahong River Channel, Phase I-III, located at Barangay Pangapisan North, Lingayen, Pangasinan;

WHEREAS, the said Project aims to reduce the overall risk of structure experiencing flood damage, as well as the severity of flood damage when it occurs, thereby enabling individuals and communities to recover more rapidly from disasters;

WHEREAS, there is a need therefore for the Sangguniang Panlalawigan of Pangasinan to pass a resolution favorably endorsing the abovementioned projects in the Province through the DPWH-Regional Office I;


WHEREAS, acknowledging the importance of the aforesaid projects to reduce the overall risk of flood damage and to ensure rapid recovery of communities from disasters, the Sangguniang Panlalawigan shall favorably endorse the projects: *Provided*, that before the start of any dredging activity, the project proponent shall pre-identify a stockyard where the minerals to be extracted shall be deposited, and provided further, that the minerals/deposits collected shall be under the jurisdiction and disposition of the Provincial Government;

NOW, THEREFORE, on motion of SP Members Salvador S. Perez, Jr. and Vici M. Ventanilla, duly seconded, it was –


