PROVINCIAL RESOLUTION NO. 417-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, AND THE ACTING PROVINCIAL TREASURER, CRISTY C. UBANDO, TO CREATE/OPEN AN AUTO-CREDIT PAYMENT SCHEME (ACPS) BANK ACCOUNT WITH LAND BANK OF THE PHILIPPINES FOR THE TB-DOTS FACILITY OF THE MANAOAG COMMUNITY HOSPITAL

WHEREAS, PhilHealth Circular No. 043, S-2012 instituted the Auto-Credit Payment Scheme (ACPS) which mandates accredited Health Care Institutions (HCIs) to open deposit accounts with LANDBANK where the payments of their claims will be credited;

WHEREAS, the Auto-Credit Payment Scheme (ACPS) is a payment scheme where hospitals' claims are directly credited to their designated deposit account with LANDBANK;

WHEREAS, to improve claim process efficiency, the issuance was amended through PHILHEALTH Circular No. 2017- 0020 which aims to automate PHILHEALTH's payment mechanism with the HCIs banking service providers;

WHEREAS, said Circular further aims to guide HCIs by prescribing standard requirements for HCI auto credit registration, official receipt information, and auto credit payment schedules;

WHEREAS, the creation/opening of an ACPS bank account with LANDBANK will be used by PhilHealth in credentialing payment for TB-DOTS patients of the Manaoag Community Hospital who have availed of TB-DOTS Package;


WHEREAS, the use of ACPS would be beneficial for the Province because it is a faster and more convenient way of claims reimbursement;
