PROVINCIAL RESOLUTION NO. 426-2024

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE PROFESSIONAL REGULATION COMMISSION (PRC) – REGIONAL OFFICE I FOR THE CONDUCT OF PRC MOBILE SERVICES DURING JOB FAIRS ORGANIZED BY THE PANGASINAN PESO WITHIN THE PROVINCE

WHEREAS, the national government has been determined in defining its role to help the local government units in the application of policies, programs and projects in order to provide services more accessible in the countryside and to generate more jobs for the people;

WHEREAS, pursuant to the provisions of RA No. 8981, commonly known as the Professional Regulation Commission (PRC) Modernization Act of 2000, the PRC is conducting mobile services as part of its initiative to efficiently extend its services to clients in remote and underserved areas;

WHEREAS, the services to be extended by the PRC shall include, but not limited to, the following transactions: Initial Registration, Renewal and Duplication of Professional Identification Cards (PIC), Processing Applications for Certification of Good Standing, Board Rating Certification, Board Passing Certification, PIC Authentication, Certificate of Registration Authentication, Continuing Professional Development (CPD Evaluation, State Board Verification, Exam Application Processing and Issuance Authentication for Board Rating and Board Passing Certifications, and Handling Petitions for Change of Status and Correction of Name/Date of Birth;

WHEREAS, the Provincial Government of Pangasinan which organizes job fairs as part of its commitment to promote employment opportunities and economic development for the people shall collaborate with the PRC Regional Office I to bring those transactions to the Province and make those mobile services more accessible and available to Pangasinenses in order to save travel time and expenses particularly for professionals and other stakeholders;

WHEREAS, the proposed agreement between the Provincial Government of Pangasinan and PRC-Regional Office I is executed to set forth the duties and obligations of the parties with respect to the implementation of the program in the Province of Pangasinan;

WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Provincial Governor Ramon V. Guico III, and the PRC Regional Office I, represented by Atty. Arl Ruth B. Sacay-Sabelo, Regional Director;

NOW THEREFORE, on motion of SP Member Jerry Agerico B. Rosario, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Honorable Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement (MOA) with the Professional Regulation Commission (PRC) – Regional Office I for the conduct of PRC Mobile Services during job fairs organized by the Pangasinan PESO within the Province;

RESOLVED FINALLY, to furnish copies of this resolution to Honorable Governor Ramon V. Guico III, Province of Pangasinan, and Atty. Arl Ruth B. Sacay-Sabelo, Regional Director, Professional Regulation Commission – Regional Office I, for their information and guidance.
