**PROVINCIAL RESOLUTION NO. 429-2024**

**RATIFYING THE MEMORANDUM OF AGREEMENT (MOA) ENTERED INTO AND SIGNED BY THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, THE LOCAL GOVERNMENT UNITS OF INFANTA, MABINI, LABRADOR, SAN CARLOS CITY, STA. BARBARA, SAN FABIAN, SISON, ASINGAN, AND NATIVIDAD, PANGASINAN, REPRESENTED BY THEIR RESPECTIVE MAYORS, AND THE FCA BENEFICIARIES AND FARMER COOPERATORS NAMELY: DOLIMAN AGRARIAN REFORM COOPERATIVE; CALZADA MULTIPURPOSE COOPERATIVE; BOLO GRAINFIELDS FARMERS ASSOCIATION, INC.; BAYBAY BOQUIG PAOAY RIVERSIDE IRRIGATORS ASSOCIATION; TULIAO CALAY IRRIGATORS ASSOCIATION; BTS AGRI-ALLIANCE INC.; SISON PINMILAPIL IRRIGATORS ASSOCIATION, INC.; CARUSUCAN SUR & DUPAC IRRIGATORS ASSOCIATION; AND SAN MAXIMO, RIZAL, CANAREM, CARRIEDO, TRENCHERA IRRIGATORS ASSOCIATION (SRCCT IA) REPRESENTED BY THEIR RESPECTIVE PRESIDENTS, FOR THE IMPLEMENTATION OF THE PROVINCIAL CORPORATE FARMING PROGRAM IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, under the Local Government Code of 1991, Local Government Units are mandated to generate and apply its resources for productive, developmental or welfare purposes in the exercise of furtherance of its governance or proprietary powers and functions;

**WHEREAS**, agriculture is the primary industry of the Province of Pangasinan. Its agriculture sector is important of inclusive growth, being a key driver of the province's economy particularly in the rural areas where farming families live. To achieve sustainable food production, it is imperative to continuously address pressing challenges and constraints that may impact on productivity and welfare of farmers;

**WHEREAS**, to address these major concerns of the agricultural sector of province, the Provincial Government under the leadership of Hon. Gov. Ramon V. Guico III is implementing the Provincial Corporate Farming Program to enhance food production and to make farming a profitable and sustainable economic enterprise in line with the national government's food sufficiency thrust under its Masagana Program for agriculture;
