PROVINCIAL RESOLUTION NO. 430-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH MS. LILIBETH D. BERNARDO FOR THE RENEWAL OF THE LEASE OF A 20-SQUARE METER PORTION, MORE OR LESS, OF HER PROPERTY COVERED BY TAX DECLARATION NO. 11-0077-00606 WITH THE INSTALLED CONTAINER VAN IN THE CONDUCT OF ANIMAL QUARANTINE CHECKPOINT BY THE PROVINCIAL VETERINARY OFFICE

WHEREAS, Republic Act No. 8485, otherwise known as “The Animal Welfare Act of 1998”, aims to protect and promote the welfare of all animals in the country by supervising the establishment and operations of all facilities utilized for breeding, maintaining, keeping, treating or training of all animals either as objects of trade or as household pets;

WHEREAS, it is the commitment of the Provincial Government of Pangasinan to safeguard the welfare of the livestock and poultry industry and deliver the veterinary health care services for the community;

WHEREAS, Mrs. Lilibeth D. Bernardo is the spouse and legal heir of the late Mr. Amado Bernardo, who is the owner of a parcel of land situated in Barangay Wawa, Bayambang, Pangasinan;

WHEREAS, the Provincial Government of Pangasinan intends to renew the lease of the 20-square meter portion of her property, a lot used in the establishment of Animal Quarantine Checkpoint and the positioning of container van utilized by the quarantine guard officers on duty 24/7;

WHEREAS, Mrs. Lilibeth D. Bernardo is also willing to lease the aforementioned subject property to the Provincial Government of Pangasinan;

WHEREAS, the term of the lease contract shall be for a period of three (3) years from May 01, 2024 to May 01, 2027, subject to renewal by mutual consent of the parties;

WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;


WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Honorable Governor Ramon V. Guico III and Ms. Liliabeth D. Bernardo;

WHEREFORE, in view of the foregoing, on motion of SP Member Nicholi Jan Louie Q. Sison, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with Ms. Liliabeth D. Bernardo for the renewal of the lease of a 20-square meter portion, more or less, of her property covered by Tax Declaration No. 11-0077-00606 with the installed container van in the conduct of animal quarantine checkpoint by the Provincial Veterinary Office;
