#### **PROVINCIAL RESOLUTION NO. 431-2024**

#### APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2024

WHEREAS, presented for consideration is the Revised Annual Investment Program of the Province of Pangasinan for Calendar Year 2024 as endorsed by the Provincial Development Council through PDC Execom Resolution No. 03-24;

WHEREAS, the AIP of the Province of Pangasinan for CY 2024 was approved by the Sangguniang Panlalawigan on October 23, 2023 through SP Resolution No. 943-2023;

WHEREAS, there is a need to revise the CY 2024 Annual Investment Program to include the disaster risk reduction management related programs and projects, specifically the stockpiling of food and non-food items to be funded out of the Special Trust Fund from the unexpended LDRRM Fund in the amount of P100,000,000.00;

WHEREAS, Section 25 of Republic Act No. 10121 provides that the unexpended Local DRRM Fund shall accrue to a Special Trust Fund solely for the purpose of supporting DRRM activities of Local DRRM Councils;

WHEREAS, the utilization of the unexpended LDRRM Fund to fund DRRM related program/project emanated from the Provincial Disaster Risk Reduction Management Council and approved through PDRRMC Resolution No. 1, Series of 2024;

WHEREAS, said stockpiling of food and non-food items project is aligned with the Provincial Government's commitment for a proactive disaster preparedness quick response and efficient recovery efforts in times of calamity, disasters and emergencies and in accordance to NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;

> WHEREAS, the abovementioned JMC also provides that the unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a Revised AIP as approved by the local sanggunian and Local Chief Executive upon recommendation of the Local Disaster Risk Reduction and Management Council in accordance with the approved Local Disaster Risk Reduction and Management Plan;

> WHEREAS, after careful study of the said Revised Annual Investment Program, this august Body finds it to be in order;
