#### **RESOLUTION NO. 433-2024**

DECLARING MUNICIPAL ORDINANCE NO. 2023-05 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING THE VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (VAWC) DESK AND PRESCRIBING RESPONSE MECHANISMS AND PROTOCOLS IN HANDLING GENDER-BASED VIOLENCE AND RAPE CASES IN EVERY BARANGAY OF THE MUNICIPALITY OF AGNO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Municipal Ordinance No. 2023-05 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 12 (D), Rule IV of the Implementing Rules and Regulations of the Republic Act No. 9710, otherwise known as the "Magna Carta of Women"; Sections 16 & 17 (a) of R. A. No. 7160; and Joint Memorandum Circular No. 2010-2 dated December 9, 2010, entitled "Guidelines in the Establishment of a Violence Against Women (VAW) Desk in every Barangay";
