RESOLUTION NO. 434-2024

DECLARING MUNICIPAL ORDINANCE NO. 2023-08 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED “AN ORDINANCE PROVIDING FOR A MENTAL HEALTH PROGRAM IN THE MUNICIPALITY OF AGNO, PROVINCE OF PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Municipal Ordinance No. 2023-08 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 15 and 37 of Republic Act No. 11036, entitled “An Act Establishing a National Mental Health Policy for the Purpose of Enhancing the Delivery of Integrated Mental Health Services, Promoting and Protecting the Rights of Persons Utilizing Psychosocial Health Services, Appropriating Funds Therefor and Other Purposes” & Section 16 of R. A. No. 7160;

WHEREAS, the created public position should comply with the budgetary limitations and rules prescribed under Section 325 of R.A No. 7160;




