RESOLUTION NO. 437-2024

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2024 OF AGNO, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P180,000,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Annual Budget for Calendar Year 2024 involving total appropriations of Php180,000,000.00 which was enacted on December 18, 2023 through Appropriation Ordinance No. 04-2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the 2024 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memo Circular No. 1, Series of 2007 dated March 8, 2007;
- 2. That the projects funded under the 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020;

- 3. That the utilization of all appropriation for Capital Outlay, shall as may be applicable, be subject to authorization of the Sangguniang on the list of projects to be implemented as ruled by the Supreme Court in the case of Hon. Gabriel Luis Quisumbing et. al vs. Hon. Gwendolyn f. Garcia, et.al G.R 1755-22, December 8, 2008;
- 4. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A No. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
- 5. That the items funded out of the Local Disaster Risk Reduction & Management Fund shall be in accordance with R.A No. 10121 known as the Philippine Disaster Risk Reduction & Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation & Utilization of the Local Disaster Risk Reduction & Management Fund (LDRRMF) & that 30% shall be set aside as Quick Response Fund:
- 6. That the grant of Step Increment to some municipal employees shall be in accordance with the CSC-DBM Joint Circular No. 1, series of 2012 dated September 3, 2012 & CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016. The appropriation for salaries of the following employees shall therefore be adjusted as follows:

- 7. That the disbursement of Magna Carta Benefits of public health workers shall be in accordance with DBM-DOH Joint Memorandum Circular No. 1, S. 2012 dated November 29, 2012 re: Rules and Regulations on the Grant of Compensation- Related Magna Carta Benefits to Public Health Workers (PHWs); and
- 8. That the employer (government) share in the premium contributions to the Home Development Mutual Fund (PAG-IBIG Fund) of the municipal officials and employees shall be adjusted pursuant to DBM Circular Letter No. 2024-2 dated February 1, 2024.
