RESOLUTION NO. 442-2024

APPROVING RESOLUTION NO. 199, S-2023 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL AIP NO. 3 CY-2023 OF THE LOCAL GOVERNMENT UNIT OF SAN FABIAN, PANGASINAN AMOUNTING TO P1,222,837.83"

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 199, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of San Fabian, Pangasinan prepared the LGU's Supplemental Annual Investment Program (SAIP) No. 3 for CY 2023. This was endorsed by the Council, through MDC Resolution No. 04-S. 2023 dated October 3, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. The Supplemental AIP, which has a total investment requirement of ₱1,222,837.83, covers the augmentation of funds for Personal Services (granting of Other Personnel Benefits) of the LGU; and
- 3. Funding support for the LGU's Supplemental AIP is embodied in their Supplemental Budget No. 2 for CY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 3, S-2023 dated December 6, 2023.
