#### **RESOLUTION NO. 444-2024**

APPROVING RESOLUTION NO. 2024-052 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 1 FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF LAOAC, PANGASINAN IN THE TOTAL AMOUNT OF THREE MILLION FIVE HUNDRED THREE THOUSAND FORTY PESOS & 97/100 (P3,503,040.97)"

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Resolution No. 2024-052 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Laoac, Pangasinan has identified items in their Supplemental Annual Investment Program No. 1. This was endorsed to the Sangguniang Bayan for approval on January 18, 2024 by the Municipal Development Council-Executive Committee thru Resolution No. 2024-01;
- The SAIP covers fund augmentation for Capital Outlay (purchase of Patient Transport Vehicle and MDRRMC Vehicle), to strengthen LGU's emergency response capabilities with a total investment requirement of Php 3,503,040.97; and

3. Funding support for the full implementation of the same is embodied in their proposed Supplemental Budget No.1 for FY 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 2024-001 on February 12, 2024.
