APPROVING RESOLUTION NO. 2023-54 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL INVESTMENT PROGRAM NO. 2023-06 OF THE SUPPLEMENTAL BUDGET NO. 2023-06 OF THE MUNICIPALITY OF SAN MANUEL, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Resolution No. 2023-54 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of San Manuel, Pangasinan has identified items in their Supplemental Annual Investment Program (SIP) No. 06 for CY 2023. This was endorsed to the Sangguniang Bayan on December 1, 2023 through MDC Resolution No. 08, Series of 2023;
2. The SIP No. 06 of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive (SRI) to government employees of LGU San Manuel), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay of some municipal offices; and

3. Funding support for the proposed Supplemental Investment Program, with a total investment requirement of PhP8,101,336.77 is embodied in the municipality's Supplemental Budget No. 06, CY 2023 which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 07, Series of 2023 on December 6, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Manuel, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan., duly seconded, it was—


